

# Stop All UK Arms to Israel!

Starmer's Labour government continues to provide arms to Israel in clear defiance of UK export guidelines. Suspending 30 out of 350 arms export licences to Israel is not enough. Our government is breaking international guidelines supposed to prevent arms sales where any of the following conditions apply:

- there is a clear risk of arms use for internal repression. Israel is currently under investigation by the International Court of Justice on the charge of committing genocide;
- there is a clear risk that the weapons might be involved in a serious violation of international humanitarian law;
- the arms exports would provoke or prolong armed conflicts or aggravate existing tensions or conflicts in the country of final destination; or
- there is a risk that the intended recipient would use the weapons aggressively against another country, or to assert by force a territorial claim.

Israel has committed all the above crimes on the Palestinian people ever since 1948. Since October 2023 these actions and violations are at the core of Israel's military occupation regime, including their destruction of Gaza and brutal repression in the West Bank. Now Israel is bombing the nations of the Lebanon, Syria and Iran, escalating the conflict into a regional war.

For the UK Government's own export guidelines to be legally upheld they must stop all arms exports to Israel. NOW!
